**MAYOR SANDERS** CALLED THE MEETING TO ORDER AT \_\_\_\_\_PM.

LINE WILL BE EXTENDED FROM DOUG LENOX HOUSE A 2" LINE DOWN 709 FOR APPROXIMATELY ½ MILE WITH FLUSH VALVE AT END OF LINE ¾" METER WILL BE INSTALLED. WITH FLUSH VALVE AT THE END OF LINE. MS. MOORE WIL BE RESPONSIBLE FOR THE LINE FROM THE DAY IT IS PUT INTO SEVICE FOR ONE YEAR, THEN IT REVERTSS BACK TO THE CITY. AFTER THAT THE CITY WILL TAKE POSSESSION OF THE LINE AND HAVE OWNERSHIP OF IT.

THE PROPERTY OWNES WILL PAY FOR ALL THE LINE EXTENSION AND WILL BE RESPONSIBLE FOR IT FROM THE DAY IT IS PUT INTO SERVICE FOR ONE YEAR. AFTER THAT THE CITY WILL TAKE POSSESSION OF THE LINE AND HAVE OWNERSHIP OF IT. **PER HAYTER ENGINEERING WILL BE ABLE TO ADD 20 HOMES.
