

**DAWSON CITY COUNCIL MEETING
SEPTEMBER 10, 2018 @ 7:00 P.M.
114 N. MAIN ST. DAWSON, TX. 76639**

Mayor Sanders called the meeting to order at 7:00 P.M. Council present were: Stephen Sanders, Greg Hall, Darrell Stevenson and Cameron Shaw. Aaron Hogue and Tony Mikeska were absent. Employees present were: Ronda Franks. Special guest Janice Southworth with Grantworks concerning 2015 Disaster Grant.

Darrell made a motion to adopt Resolution to designate authorized signatures for the 2015 Flood Allocation CDBG disaster recovery program contract. **Greg** seconded the motion, all in favor, motion passed.

Darrell made a motion to approve a resolution adopting required CDBG-DR Civil Rights policy. **Cameron** seconded the motion, all in favor, motion passed.

Greg made a motion proclaiming April as Fair Housing Month. **Darrell** seconded the motion, all in favor, motion passed.

Violet gave the Municipal report. She collected \$11,124.18 in August of that the State gets \$4,633.01 and the City gets \$6,491.17.

The **Mayor** read **Violet's** letter of retirement, stating that her last day would be October 01, 2018.

Council asked Ronda to run a ad in the Corsicana Daily Sun for help wanted to fill the court clerk position for two weeks and put on October agenda.

Darrell made a motion to have Zero turn mower motor replaced by Ludwig Saw & Tool in Waco for approximately \$920.00 - \$950.00 as per quote. **Greg** seconded the motion, all in favor, motion passed.

Council went over Police report.

Cameron made a motion to approve the August 06, 2018 Minutes. **Darrell** seconded the motion all in favor motion passed.

Darrell made a motion to approve the August 16, 2018 Minutes. **Greg** seconded the motion all in favor motion passed.

Greg made a motion to approve the Financial report. **Darrell** seconded the motion all in favor motion passed.

Greg made a motion to approve Paying of the Bills subject to inspection. **Darrell** seconded the motion all in favor motion passed.

Cameron made a motion to adopt the **Property Tax Rate for 2018-19 at 0.430800/\$100**. **Darrell** seconded the motion, all in favor, motion passed.

Council decided to **table** possibly revising **Ordinance 1999-9 Mobile Homes** for now. Put on next month's agenda giving council time to look over and see what needs to be changed.

Cameron made a motion to not have any unpaid reserve officers at this time. **Greg** seconded the motion, all in favor, motion passed.

The purchasing of a new lap top for the Ford Unit 1701 was tabled until a later date. Possibly after the Dodge Unit 601 is back up and running.

Darrell made a motion to have **Mart Auto** replace the motor in Unit 601-Dodge for \$5114.00 with a 3 year unlimited mile warranty and to also see how much it would be to look at the electrical system and possibly fix.

Greg seconded the motion, all in favor, motion passed.

Darrell made a motion to adjourn the meeting since there is no further business to discuss. **Cameron** seconded the motion, all in favor, motion passed.
