

**DAWSON CITY COUNCIL SPECIAL CALLED MEETING MINUTES**

1. **MAYOR** TO CALL MEETING TO ORDER @ 6:00pm.  
PRESENT AT THIS MEETING WERE: MAYOR STEPHEN SANDERS, BARBARA ADLER MAYOR PRO-TEM, DARRELL STEVENSON, CAMERON SHAW, CHUCK RAINES AND AARON HOGUE. EMPLOYEE PRESENT WERE: RONDA FRANKS. SPECIAL GUEST WERE: DAN TEED THE NAVARRO COUNTY ELECTION COORDINATOR, LAURIE SANDERS, MARTY STEVENSON, TONY MIKESKA, KIM MIKESKA, CANDICE GREER, HILAH BROCK, SHALINA BROCK, ANN MOTT, JERRY PIERCE, BRYAN PRATER.
2. DISCUSS AND ACT UPON **CANVASSING THE VOTES** FOR THE GENERAL ELECTION COUNCIL MEMBERS AND BOND. **Mr. DAN TEED** SPOKE TO THE COUNCIL AND AUDIENCE LETTING EVERYONE KNOW THAT THE BALLOTS FOR THE CITY OF DAWSON GENERAL ELECTION AND BOND ELECTION HAD BEEN RE-COUNTED AND THE COUNT REMAINED THE SAME AS ORIGINAL COUNT.

**BARBARA ADLER** AND **AARON HOGUE** READ ALOUD THE **OATH OF OFFICE** AND BOTH SWORE TO FAITHFULLY EXECUTE THE DUTIES OF THE OFFICE OF CITY COUNCIL MEMBERS OF THE STATE OF TEXAS.

**WILL AND VICTORIA DICKSON** ASK CHRIS FOLEY ABOUT PUTTING GRAVEL ON 3<sup>RD</sup> STREET IN HOLES UNTIL STREET CAN BE REPAIRED AND SIGNS THAT SAY CHILDREN AT PLAY AND SPEED LIMIT 30MPH. COMMENTS FROM MAYOR AND COUNCIL CANDICE GREER ASKED ABOUT HER SIDEWALK REPAIR AND WAS TOLD IT WOULD BE ON THE NEXT REGULAR MEETING AGENDA.
