\*You may plead **GUILTY** and remit the fine. (See  
schedule of fines.)

\*You may plead **NO CONTEST** and remit the fine.

\*You may plead **NOT GUILTY** and request a  
Trial by Judge or Trial by Jury.

\*If you plead **NO CONTEST** or **GUILTY**, and  
if you qualify, you may take a Driver's Safety Course.  
(See Driver's Safety Course eligibility & procedures.)

**A plea must be made in writing on or before  
the appearance date shown on the citation.**

**A telephone call does not constitute as your  
appearance or count as your plea.**

### PLEA FORM:

### ~Driver Safety Information~

#### To be eligible for Driver Safety Course:

\*Possess Valid Texas Driver's License or Proof of Active  
Military Duty (**No exceptions**)

\*DSC not taken in past 12 months (or currently taking)  
for any traffic violation (**No exceptions**)

\*Motor Vehicle Liability Insurance must be in effect  
the date of the violation (**No exceptions**)

\*A speeding violation **must be less than 25mph**. If the  
speeding violation is 25mph and over you will **NOT** be  
eligible for the Drivers Safety Course. (**No exceptions**)

\*A driver who has a **CDL license is not eligible** for DSC  
or Deferred Disposition. (**No exceptions**)

\*The Court **must receive** a written **plea** of Guilty or  
No Contest, **request** for **DSC**, copy of valid proof of

**insurance**, copy of valid **Driver's License**, a copy  
of **driving record #3A \$12.00** obtained from

**www.dps.gov** and **\$144.00 if in SCHOOL ZONE**  
**the fee will be \$169.00** paid to the court on

**OR before** the appearance date on citation. Approval  
for DSC must be granted by the Court. (**No exceptions**)

\*The DSC must be state approved, whether thru a  
class, DVD, or online. (**No exceptions**)

\*Once approved, you are allowed a period of

**90 days** for the completion of the necessary  
requirements for DSC dismissal. **The Court**

**must receive all of the required signed**

**documents within the 90 day period.**

**There are no time extensions allowed**

**and there are NO EXCEPTIONS!**

\*\*\*Deferrals are granted at the Judge's discretion and  
are not guaranteed to be approved.

The following are the standard fines with the State costs added for the violations shown. If the offense you were cited for is not on the list or you are not sure which fine applies, please contact the court 72 hours AFTER receiving citation & have your citation number available for information. Any person receiving a citation and taken to Navarro County Jail must contact the court by telephone within 10 business days.

POLICE OFFICERS CANNOT ANSWER QUESTIONS ABOUT FINE AMOUNTS OR COURT PROCEDURES. DO NOT CALL THE POLICE DEPARTMENT FOR INFORMATION ABOUT YOUR CITATIONS OR FINES.

**IF YOU HAVE QUESTIONS, PLEASE CONTACT THE COURT DIRECTLY!**

Failure to comply with your signed promise to appear in court, as stated on your citation, will constitute a separate offense with which you may be charged and result in warrants being issued for your arrest. Failure to comply will make you subject to entry into the wanted person's files of this Court.

FAILURE TO APPEAR IN COURT MAY ALSO RESULT IN THE DENIAL OF RENEWAL OF YOUR DRIVER LICENSE.

The judgment and sentence for the offense for which you are charged is the payment of a fine and costs. If ordered to pay a fine and cost and you cannot pay the full amount, please contact the court. If you are determined to have insufficient resources or income to pay in full, the Court can provide you other alternatives to discharge the fine, fees, and cost.

If your offense is that of **Expired Driver's License, Motor Vehicle Inspection or Registration** and you are submitting the proof of renewal, the expiration must be less than 60 days.

Please remember to include a copy of the proof of the renewal, your plea and the dismissal fee of **\$20.00**. The Court **must** have these three items to dismiss the offense.

**IF YOUR OFFENSE IS FOR NO INSURANCE, SUBMIT A COPY OF VALID PROOF OF INSURANCE VALID ON THE DATE OF CITATION.**

"If you are convicted of a misdemeanor offense involving violence where you are or were a spouse, intimate partner, parent or guardian or other familial relationship with the victim, it may be unlawful for you to possess or purchase a firearm, including handgun, long gun or ammunition, pursuant to federal law under 18 U.S.C. Section 922 (g) (9) or Section 46.04 (b), Texas Penal Code. If you have any questions whether these laws make it illegal for you to possess or purchase a firearm and/or ammunition you should consult an attorney."
